IMPORTANT INSTALLATION INFORMATION

- Installation should be carried out in accordance with the latest edition of the NEC / IEEE Wiring Regulations.
- For use with Illuminous 12V AC **constant voltage Halogen or Incandescent** products, **will NOT work with LED**

IMPORTANT.

- Constant voltage Fittings **MUST be wired in PARALLEL**. Failure to do so can cause permanent luminaire and/or transformer failure.
- **PLEASE NOTE: 12V AC Output (Not Polarized)**

INSTALLATION INSTRUCTIONS

- Before commencing installation or maintenance, **ensure electricity is switched off at the mains**.
- Keep the transformer away from direct sources of heat such as Low Voltage lamps.
- Insure that ALL electrical connections are tight with no loose strands.
- This transformer can be used with a dimmer on the input 110V-120V AC side. See list below for tested Dimmers.
- Suitable for direct mounting on or in cabinets or furniture
- Do not fit the transformer above the luminaire
- Ensure that the transformer is not covered with insulation material and has an air gap of 50mm around the transformer.

Connect the mains cable to the mains supply.

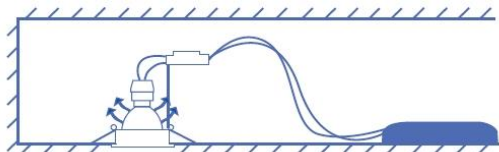
AC input is to the 2 Wires as follows:

- Live / Hot = BLACK
- Neutral = WHITE

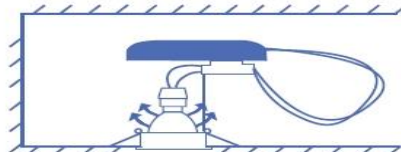
Connect the outputs to the Lamp:

12V AC Halogen or Incandescent lamps.

AC output is to the 2 x RED Wires, they are NOT Polarized
